New York-based Israeli pianist; faculty member, Manhattan School of Music; associate faculty, the Juilliard School; also teaches in the framework of Young Artists Program at Kaufman Center, New York City, Puerto Piano International Festival, Adamant Summer Music School in Vermont, and Morningside Music Bridge summer program. Performed with Moscow Chamber Orchestra, Shanghai Symphony, Lithuanian National Symphony, Lithuanian Chamber Orchestra, Cincinnati, and Ann Arbor Symphonies. She was a guest artist in Mozarteum Festival in Salzburg, Vilnius Festival in Lithuania, St. Petersburg Palaces Festival in Russia, Puigcerda Music festival in Spain, International Academy in Italy, Shanghai Conservatory International Festival, and the Shanghai Himalayas International Piano Festival. A Steinway artist. Her recordings include "The Portrait" (a solo recital, on FPI label), Mozart piano concertos with Moscow Chamber Orchestra (Consonance, USA). Her CD with piano music by Robert Schumann (3D, France) received critical acclaim from American Record Guide magazine. Moisei Vainberg's piano Quintet with Vilnius String Quartet was released on Delos. Among her teachers -- Bella Davidovich, Nina Svetlanova, Rosalyn Tureck, Mindru Katz, Emanuel Krasovsky. She is founding director of Tureck International Bach Competition for Young Pianists in New York, assigned that task by Rosalyn Tureck in 2003.
